Course Description

We have long understood that the arteries bring oxygen to the tissues and the veins take carbon dioxide and metabolic byproducts away. What has not been as clear is the interaction between the vessels, the nervous system, the mechanics of the musculoskeletal system, the fascial, and local blood flow regulation. Even less clear is what happens in between the arteries and veins, the micro perfusion at the level of the capillaries. Scientific studies have recently shown that the micro perfusion is the key to health, when talking about any internal organ, the brain, the nervous system, basically any anatomical structure. In any dysfunction, either somatic, visceral, or cranial, the micro perfusion is impaired. Therefore, if we can palpate arteries, veins, lymphatics and the micro perfusion in between, we are able to have a clear diagnosis, and can evaluate post treatment our success or lack of success.
